The regular program sessions will be mostly held on the second Wednesday of each month, whenever possible, and conclude in October followed by graduation in November (The sessions are generally shorter day sessions during the summer months of June, July and August, but that is determined based on speakers schedules and varies from year to year).

In order for Leadership Bellevue to accomplish its stated goals, the full participation of each individual is mandatory. If you are unable to make that commitment, it is not in your best interest to apply at this time. The following will result in termination from the program with no tuition refund:
